# MISBO EANS Quick Reference Guide



### What is EANS?

EANS is an acronym for the Emergency Assistance to Non-Public Schools relief program. This government funding has been made available to each State Governor to provide to non-public schools in each of their respective States as a part of the Coronavirus Response and Relief Supplemental Appropriations Act (also know as CRRSA).

This EANS grant funding for each State is intended to provide services and assistance to non-public schools which enroll a significant percentage of low-income students and have been most impacted by the COVID-19 pandemic.

Who is eligible for EANS funds?

For the purposes of EANS funding, an eligible non-public school



is an elementary or secondary school that is:

## Non-profit

Accredited, licensed, or otherwise operates in accordance with State law



Was in existence prior to March 13, 2020, the date the President declared the national emergency due to COVID-19



Did not, and will not, apply for and receive a loan under the PPP (15 U.S.C. 636[a][37]) that is made on or after December 27, 2020



### What are allowable uses for EANS funds?

Southeastern Paper Group and other Envoy Solutions affiliates can assist with the following uses of EANS funds:















#### **Sanitation Supplies**

EANS funds may be used to purchase sanitation, disinfectant, and cleaning supplies for school facilities.

#### Personal Protective Equipment

EANS funds may be used to purchase PPE for adults and students to help stop the spread of COVID-19.

#### Ventilation, Windows, & Portable Air Purification Systems

EANS funds may be used to repair or upgrade existing ventillation systems and windows, and to provide portable air purification systems to help limit the spread of COVID-19.

# Training to Minimize the Spread

EANS funds may be used for training and professional development for staff on sanitization, the use of PPE, and minimizing the spread of infectious diseases. EANS funds may also be used to support the following:





#### **Physical Barriers**

EANS funds may be used to purchase physical barriers to help stop the spread of COVID-19.

#### Leasing Sites

EANS funds may be used to lease sites in order to assist with social distancing.



#### COVID-19 Testing

EANS funds may be used to purchase COVID-19 testing.



#### **Educational Technology**

EANS funds may be used to purchase educational technology.







#### Support for Learning Loss

EANS funds may be used for initiating and maintaining education and support services to address learning loss.

# Reasonable Transportation Costs

EANS funds may be used for reasonable transportation costs to assist with social distancing.

#### **CDC Recommendations**

EANS funds may be used to assist with certain <u>CDC</u>

Recommendations to help stop the spread of COVID-19.

### How do I get started with an EANS program?

Several of the States are utilizing the services of ClassWallet to manage the distribution of EANS funds. Below, you can follow these five steps for making purchases using EANS funds managed by ClassWallet:

- 1. SEPG Sales Consultant provides quote to School for desired supplies or services.
- 2. School uploads quote to ClassWallet portal for approval by the Department of Education.
- 3. Department of Education approves order and provides email notification.
- 4. Order is placed by SEPG, and product is shipped to School.
- 5. Reimbursement is made in 2-6 weeks.
