

## Two Critical Trends in Instruction: Are you Ready for this Fall?

As we get close to winding down this school year, and Fall starts to enter our distant horizon, it's worth considering all that's changed this school year. Much like the rest of the world which is changing rapidly, adapting to new educational trends can offer significant time savings, and in some cases may be a necessity to ensure that instruction undisturbed amidst all the recent changes in technology.

So, as you wind down this year, ask yourself if you're ready for these two important trends next Fall:

### 1. Students using ChatGPT on everything.

**The Problem:** When Microsoft-backed OpenAI released their "ChatGPT" artificial intelligence chatbot earlier this year (which if you haven't already heard about it... check it out at [www.chat.openai.com](http://www.chat.openai.com)), nearly every industry from engineers, to artists, and writers, were concerned that they would be out of a job due to how quickly ChatGPT can generate incredibly detailed, human-seeming conversation, answers, and even full essays. Soon, it became clear to most educators that the primary use-case for ChatGPT was, unfortunately, as a tool to write academic essays and cheat in online exams. While there is immense value in this technological advancement, it cannot come at the cost of our own human education.

**How Schools are Solving it:** While some ChatGPT detection tools sprang up quickly in response to ChatGPT, they are easily defeated with even simple changes to a few words to make content seem more human. With the release of the new generation ChatGPT-4, these tools are now sometimes even fooled by unedited content directly from GPT-4. Luckily, Wise Education has created a simple tool called "Authoriginal" or "AO" for short, that completely prevents the use of ChatGPT, other AI assistants, and other forms of plagiarism, while not impacting the student writing experience in any way. As a simple LMS-integrated applet, schools are seeing Authoriginal as a simple and effective way to prevent rampant ChatGPT plagiarism.

**How Schools are Solving it:** While most schools are still doing it the old fashioned way, some schools have rushed to 'digitize' attendance and have implemented large, command-and-control type systems that can automate and manage everything from attendance compliance to parent requests and excused absences. What many of these schools are finding is that too much tech and automation can be detrimental, as these large systems are just as bulky and time consuming to use as doing it the old fashioned way.
